

**Regulations of the event "Black sea half marathon 2018"**

**2018**

**Sevastopol**

## **1. THE PURPOSES OF THE CONTEST**

"Black sea half marathon 2018 "(hereinafter – "Competition") is held with the following purposes:

- promotion of healthy lifestyle;
- involving the population in active physical training and sport;
- development of mass sports;
- stimulation of the growth of sports achievements in the long run distances;
- development of sports tourism.

## **2. DATE AND THE VENUE OF THE COMPETITION**

Date of the Competition: 20 – 21 of October 2018.

The venue of the Competition: Sevastopol

## **3. SCHEDULE OF THE COMPETITION**

### **20.10.2018**

11:00 – 19:00 – the time of EXPO work and hanging out of starting packages to the participants

### **21.10.2018**

07:00 – 9:00 – cloakrooms and lockers

8:30 – 8:40 – warming up

8:40 – 9:00 – gathering of participants in the start area

9:00 – start time

10:30 – 14:30 – awarding ceremony

12:00 – cut of time

#### **4. THE ADMINISTRATION OF THE COMPETITION.**

The organizers of the Competition:

All-Russian Physical culture and Sports Society «Labor Reserves»

Non-profit organization "Fund for support and development of physical culture and sport"

Sole proprietor Berezin O. G. (hereinafter – «Responsible Organizer»).

#### **5. ORGANIZATION AND HOSTING EXPENSES ON THE COMPETITION.**

Preparation and holding of the Competition is carried out with the financing share of "Fund of Sport" (at the expense of its own and attracted funds) and Berezin O. G. (at the expense of his own funds and fund raising from participants.)

Travel, accommodation and meals expenses are covered by the organizations, which send the participants or by participants themselves.

#### **6. DISTANCES AND PARTICIPANTS OF THE COMPETITION.**

**Individual participation:** 10km, 21,1km.

Admissible for a **10 km** run are all women and men, from 14 and older, interested in competing.

Admissible for a **21,1 km** are all women and men, from 18 and older, interested in competing.

**Relay** (hereinafter – "Relay"): Admissible for a relay race 4 x 5275 m are all women and men, from 18 and older, interested in competing. Team roster must be mixed: 4 people, not less than one of another gender, participants in each stage chosen by a team.

Age of the participant of the Contest is defined at the time of the actual date of the Competition.

## 7. REGISTRATION.

**Electronic registration** of the participants at the 21,1 km, 10 km distance and at the Relay will be opened from **12:00 01.06.2018** to **12:00 15.10.2018** on the website [www.newrunners.ru](http://www.newrunners.ru)

The participant **of the individual competition** is considered to be registered, if he/she filled the application form and paid the application fee. During the registration, the participant must indicate personal details according to his/her ID. The registration of the participant will be annulled, if the data, indicated by the participant, is false, inaccurate or incomplete. In case of the annulment of the registration, there is no refund. The registration can be closed earlier if the total limit of participants at all the distances is reached. There is a limit of the participants of the contest: not more than 2000 people in total at all the distances.

During the registration **for the Relay**, the team representative must indicate personal data according to the ID of the participants of the team. The team is considered to be registered, if its representative filled the application form and paid the registration fee for the team. During the registration the team representative must register the participants of the team in the sequence, in which the participants will run the distance of the relay.

**The additional registration** at the distance will be opened only 20.10.2018 in case, if the limit of the participants of the Competition is not reached till the moment of the closure of the electronic registration 15.10.2018.

The registration and the hanging out of starting packages will not be performed 21.10.2018.

## 8. RE-REGISTRATION TO A THIRD PARTY AND DISTANCE REPLACEMENT.

8.1 At the 10 km and 21,1 km distance the registered participant can **re-register to a third party**, which is not registered at the Competition, at the period from **01.08.2018 to 12:00 03.10.2018**. For the re-registration, the registered participant must do the re-registration through a personal account on the website

[www.newrunners.ru](http://www.newrunners.ru). The cost of the re-registration is 300 rubles. The re-registration fee is paid by the new registered participant.

At the 10 km and 21,1 km distance the registered participant **can change the distance** at the period from **01.08.2018 to 12:00 03.10.2018**. In case if the registration fee for the new distance is higher than the registration fee for the former distance, the participant must pay the difference till the actual registration fee and also must pay the service for the distance replacement. In case if the registration fee for the new distance is less than the fee for the former distance, only service for the distance replacement must be paid (there will be no refund for the difference for the registration fee). The distance replacement must be preformed through a personal account on the website [www.newrunners.ru](http://www.newrunners.ru), the participant must pay the difference of registration fees (if it is necessary) and the service for the distance replacement.

8.2. For the re-registration of the participant of the **relay**, the team representative must write the application about the re-registration and send it to the e-mail: [relay@newrunners.ru](mailto:relay@newrunners.ru) at the period **from 12:00 01.08.2018 to 12:00 19.10.2018**.

## **9. CONDITIONS OF ADMISSION TO THE COMPETITION AT THE 10 KM DISTANCE, 21.100 KM DISTANCE AND THE RELAY.**

Admission of the participants to the Competition is performed provided that he/she has the following documents which are given to the Mandate commission during the receiving of starting package of the participant:

- **ID**, which proves the age of the participant (**obligatory for all the participants**)
- original **medical certificate** in which it should be stated that the participant is allowed to take part in the competition at a distance of his choice or a longer distance (required for all participants).

By providing these documents to the Mandate commission with the purposes of the admission to participation in the Competition, the participant guarantees and confirms that he is in good physical condition, regularly does medical inspections in order to ensure the safety of participation in the Competition for his health in accordance with the part 5 of Art. 24 of the Federal law No. 329-FL of 04.12.2007 "on physical culture and sports in Russia", also that he has no medical or other

health restrictions which may cause harm or limit his participation in the Competition, including absence of restrictions on lengthy physical activities and his health condition allows him to participate in the Competition.

The participant takes the whole responsibility for authenticity of the certificate, its obtaining in order determined by law on the basis of conducted medical examination and in the authorized medical agency. The participant does not object against the possible provision of the first aid, provided by the organizers.

For the participants from 14-17 y.o. in addition to the mentioned documents parents' (or legitimate representatives') consent to participation of under age child in the competition should be obtained. Children under the age of 14 are not allowed to participate.

Medical documents should be ready starting from **21.04.2018**

## **10.STARTING PACKAGE**

**Starting package** of the participant **for the 10 km distance** contains:

buff

running bib

chip for the result monitoring

water

medal ( at the finish line)

**Starting package** of the participant **for the 21,1 km distance** contains:

T-shirt

running bib

chip for the result monitoring

water

medal ( at the finish line)

**Starting package** of the participant of the **Relay** contains:

T-shirt

running bib

chip for the result monitoring

water

medal ( at the finish line)

**Hanging out of starting packages of the participants** will be performed **20.10.2018 from 11:00 to 19:00.**

Water and the medal, included in the starting package, will be received by the participant at the finish of the Contest.

## **11.REGISTRATION FEE**

**Registration fee for 10 km distance (limit is 800 spaces):**

First 200 registrations - 1000 rubles;

Registrations from 201 to 800 - 1200 rubles.

**Registration fee for 21,1 km distance (limit is 800 spaces)**

First 200 registrations - 1200 rubles;

Registration from 201 to 800 - 1400 rubles.

**Registration fee for the Relay with 4 person team (limit is 100 teams, 400 people)**

First 30 teams - 5000 rubles;

Registration from 31 to 100 - 6000 rubles.

For participants, who reached **pension age** (men of 60-and-over, women of 55-and-older), there is a discount 50% on 21,1 and 10 km runs.

## **12. REGISTRATION FEE PAYMENT**

Registration fee payment is performed by the participants through the online payment on the website [www.newrunners.ru](http://www.newrunners.ru).

Payment by cash will be possible only during the additional registration at EXPO, which will be performed 20.10.2018 provided that the limit of the participants at all the distances is not reached earlier.

### **13. THE RETURN OF THE FEE PAYMENT**

According to the public offer agreement, accepted by the participant during the registration, there is no fee payment refund.

### **14. THE REGISTRATION OF THE RESULTS.**

The results of the Competition are fixed by:

- Electronic timing
- Manual recording, performed by arbiters.

The final results will be published on the webpage of the Competition on the website [www.newrunners.ru](http://www.newrunners.ru) not earlier than 05.11.2018.

The organizing Committee of the Competition does not guarantee the receiving by every participant of the individual result in the following cases:

- The participant has incorrectly attached running bib (running bib must be worn on breast over the clothes)
- The participant was running with the running bib of the other participant
- The electronic chip was demagnetized, broken, smashed, etc.
- Bib was lost

### **15. AWARDING OF WINNERS OF THE COMPETITION**

The top 3 overall men and women and the top 3 50-and-over will be awarded **at the 10 km distance.**

The top 3 overall men and women and the top 3 50-and-over will be awarded **at the 21,1 km distance**

The top 6 will be awarded in team competition **at the Relay.**



The awarding of winners and prizewinners in individual competition will be based on guntime.

Place and time of other participants and participants of the Relay will be based on net time.

## **16. PROTESTS AND CLAIMS APPLICATION.**

The participant has the right to lodge a protest or a claim, which will be considered by a panel of arbiters, which consists of: chief arbiter, senior arbiter of start and finish zone and the secretary the Competition.

To the protests can be related the following:

- protests and claims , which can affect the prize places
- protests and claims, which can refer to inaccuracies in time measurement
- protests and claims, which refer to the disqualification of the participant for his/her non-sporting behavior

It is necessary to indicate the following data in the claim application:

- name and surname (anonymous claims will not be considered)
- essence of the claim
- materials, which prove a mistake (photo and video shootings)

The data of the individual time measurement instruments will not be considered.

Only the claims from the official participants of the Competition or from the third parties, who are legitimate representatives of the participants.

Decision about reconsideration of prize places are taken by the Director of the Competition.

A protest or a claim must be sent in a written form to the e-mail [protest@newrunners.ru](mailto:protest@newrunners.ru) till 18:00 04.11.2018.

## **17.DISQUALIFICATION**

Panel of arbiters reserves the right to disqualify the participant if:

- the participant was running under the bib of the other registered participant

- the participant was running the distance, at which he was not registered
- the participant used improvises means of transport (a bike, a scooter, automatic mean of transport, etc.)
- the participant began to run the distance before the official start
- the participant reached the finish line after the closure of the finish zone
- the participant began to run not from the start zone
- the participant did not provide the medical certificate, which allows him to participate in the Competition
- the participant was running without the official bib of the Competition
- the participant was running without the official bib of the Competition or the participant's bib was covered under the clothes

## **19.PHOTO AND VIDEO SHOOTING.**

Organizers perform photo and video shooting of the Competition without any restrictions and reserve the right to use the materials, which they got during the Competition, at their discretion.

## **20.CHARITY**

A collection of donations is carried out in the framework of the event “Black sea half marathon 2018” with the aim to support the activities of Non-profit organization “Sergey Belogolovtsev’s “DreamSki” center of social help and adaptation for people with cerebral palsy and other disabilities”. The activities of the abovementioned organization are targeted at the contribution to the sphere of prevention and protection of health of citizens, particularly, the activities are targeted at the providing the opportunities for self-realization and strengthening health of people with disabilities. The minimum contribution is 50 rubles.
